The term of office for Pastoral Coordinator in the Archdiocese of Seattle is generally one to three years.

SENIOR PRIEST



Rev. Stephen C. Rowan, effective October 4, 2014.

PASTOR: A priest appointed by the Archbishop and delegated as the leaders of a particular parish entrusted to him. The pastor's role, expressed in its threefold mission of teaching, governing and sanctifying (CIC, c. 519), empowers the laity for their mission as light and leaven in the world.

PRIEST MODERATOR: A priest appointed by the Archbishop with powers and faculties of a pastor of a parish. His role is to monitor and mentor the pastoral coordinator and parish priest and to act as canonical pastor to the parish community to whom a pastoral coordinator has been appointed.

PRIEST ADMINISTRATOR: A priest appointed by the Archbishop as a temporary leader of a particular parish with the same responsibilities as a pastor. (CIC, c. 540 §1-3). This office may be held, for example, by seasoned, newly arrived priests or by newly ordained priests who require more experience and formation before being assigned as pastors.

PAROCHIAL VICAR: A priest who renders service in pastoral ministry as a co-worker with the pastor, and sharing service in pastoral ministry through common counsel and effort and under his authority (CIC, c. 545 §1-2).

PASTORAL COORDINATOR: A deacon, religious or lay ecclesial minister appointed by the Archbishop under the supervision of a priest moderator and entrusted with the day-to-day leadership of a parish. (CIC, c. 517 §2).
